#### **INSIGHT Terms and Conditions**

## for the promotional contest of "INSIGHT TV LAUNCH EVENT"

#### 14 October - 28 October 2019

- 1. These are the terms and conditions (the "Terms and Conditions") for INSIGHT's promotional competition of for the promotion of INSIGHT's Epic Exploring Competition (the "Promotion").
- 2. The Promotion is brought to you by INSIGHT. References in these Terms and Conditions to INSIGHT are to TV Entertainment Reality Network B.V. a company registered in the Netherlands under company number 61267252, with its place of business at Hullenbergweg 413, 5<sup>th</sup> Floor, 1101 CS, Amsterdam Zuidoost, the Netherlands.
- 3. A person participating in this Promotion, (the "Participant"), agrees to be fully and unconditionally bound by these Terms and Conditions, and represents and warrants that they meet the eligibility requirements. In addition, the Participant agrees to accept the decisions of INSIGHT as final and binding as those decisions relate to the content of this Promotion.

#### **Duration**

4. The Promotion commences on 14 October 2019 at 16:00 CET and ends on 28 October 2019 at 23:59 CET. (the "**Promotion Period**"). The competition has been extended from its original date, which was 21 October 2019.

# Eligibility to enter

- 5. Entry into the Promotion is open to all who have reached the age of 18 and fulfilled the conditions of paragraph 7.
- 6. Directors, management and employees including their immediate families of INSIGHT and its related bodies corporate are excluded from entering the Promotion.

# **Entry into the Promotion**

- 7. Participants may participate as many times as they wish within the Promotion Period. To enter the Promotion, a Participant must, during the Promotion Period:
  - a. Follow INSIGHT's Instagram account.

## Selection of winner(s)

- 10. Within one (1) week after the Promotion Period, of all Participants that have fulfilled all conditions, 2 (two) winners shall be selected at INSIGHT's sole discretion, and based on the creativity of their Instagram story.
- 11. One (1) winner will be selected from the United States of America; and one (1) other winner will be selected from a country located outside of the United States of America.
- 12. The selected winner from the United States of America shall win the prize (as further described in paragraph 15). The winner shall be notified by direct contact via Instagram.
- 13. The selected winner from outside the United States of America shall win the prize (as further described in paragraph 16) The winner shall be notified by direct contact via Instagram.

### The prize

- 15. The winner from the United States of America will receive a trip with a friend of 2 (two) days in a selected location (TBC) within the United States of America, including travel and hotel, and a one-day exploring trip with the host of the show.

- 17. Both prizes stated in paragraphs 15 and 16 do not include any other expenses than what has been highlighted above.

All expenses and incidental travel costs not expressly stated in the package description above, including but not limited to, ground transportation, meals, incidentals, gratuities, passenger tariffs or duties, airline fees, surcharges, airport fees, service charges or facility charges, personal charges at lodging, security fees, taxes or other expenses are the responsibility solely of winner. Winner's travel companion must be at least eighteen (18) years of age or older as of the date of departure and must travel on same itinerary and at the same time as the winner.
- 23. INSIGHT will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates. INSIGHT (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury or any loss or damage otherwise arising out of or in connection, directly or indirectly, with the Promotion, the prize, technical difficulties or equipment malfunction (whether or not under INSIGHT's control).
- 24. INSIGHT reserves the right to substitute a prize (or a component thereof) for one of equal or greater value if the designated prize should become unavailable for any reason.
- 25.     - in and to the Participant's Promotion entry and otherwise arising in connection with the Promotion entry to which the Participant may now or at any time in the future be entitled anywhere in the world.
- 28. The Participant agrees that INSIGHT may, but is not required to, make the Participant's entry available on its website and any other media, whether now known or invented in the future, and in connection with any publicity of the Promotion and of INSIGHT. The Participant agrees to grant INSIGHT a non-exclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights in the Promotion entry, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the Promotion entry.

### Notification of the winner

29. The winner will be notified by INSIGHT within one week of being selected. If the winner does not respond within 48 hours the prize may be forfeited and INSIGHT may, at its discretion, select an alternate winner. The winner will be requested to provide the necessary contact

- details. Each winner and its companion must travel on the dates determined by INSIGHT in its sole discretion or prize will be forfeited.
- 30. INSIGHT reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion should a virus, bug, non-authorized human intervention, fraud, or other cause beyond Insight's control corrupt or affect the administration, security, fairness, or proper conduct of the Promotion. In such case, INSIGHT may draw a winner from all eligible entries received prior to and/or after (if appropriate) the action taken by INSIGHT.

## **Entry details and privacy**

- 31. Acceptance of the prize constitutes permission for INSIGHT to use the winner's name and entry for purposes of promoting INSIGHT without further compensation, unless prohibited by law. Personal data shall not be disclosed to any third party without explicit prior consent.
- 32. INSIGHT will use Participant's personal data provided in connection with this Promotion for the purposes of facilitating the conduct of the Promotion and awarding any prizes (including to any applicable statutory authorities) and to conduct marketing activities. Without limiting the foregoing, information submitted with an entry connection with this Promotion is subject to Insight's <u>Privacy Policy</u> as stated on www.insight.tv.

## Limitation of liability and variation of terms

- 34. If any act, omission, event, technical errors or circumstance occurs which is beyond the reasonable control of INSIGHT and which prevents INSIGHT from complying with these Terms and Conditions, INSIGHT will not be liable for any failure to perform or delay in performing its obligations. INSIGHT reserves the right (subject to any applicable law) to cancel, terminate or modify or suspend the Promotion.

INSIGHT, its related bodies corporate and their respective officers, employees and contractors will not be liable for any losses, damages, expenses, costs or personal injuries arising out of this Promotion, the Promotion or the use of the prize, including but not limited to any breach of these Terms and Conditions, contract or tort (including negligence) and any other common law, equitable or statutory remedy ("Damage") whatsoever, including but not limited to direct, indirect and consequential Damage, including Damage that cannot reasonably be considered to arise naturally and in the ordinary course of things.
